The Regulations Amending the Tobacco Products Regulations (Plain and Standardized Appearance) (Regulations) bring Canada into full compliance with its international tobacco labelling requirements by extending the display of health warnings and toxicity information to all tobacco product packages. They also introduce a rotation scheme for all health-related messages. The Regulations introduce a mandatory display of health warnings directly on individual cigarettes, little cigars that have tipping paper, and tubes.

This is because there has been some confusion regarding the interpretation of clause 15 of Schedule 5 of the Regulations relating to vaping products. This clause states that the strength of nicotine salt in a vaping substance must not exceed 50mg/mL.
