Ross (Case No. 34-2021-80003765) concerning enforcement of Proposition 12 with respect to whole pork meat. The Court's new order provides that the previously issued injunction against enforcement expires as scheduled on 1 July 2023, except with respect to certain noncompliant whole pork meat that is already in the stream of commerce (as detailed in the Court's order), which may be sold through 31 December 2023.
