These products are intended for a child who cannot sit unaided, roll over or push up on its hands and knees, with a maximum weight of 9 kg. and include all types of carry cot with rigid or soft sides as well as Moses baskets and any similar products.

If the changing unit can be converted or used as another function it shall comply with other relevant standards, e.g. cots, storage furniture, etc. The changing unit may be foldable and can be fitted with a child bathtub or other
