In order to improve the safety and quality of medical devices, Switzerland adapted its legislation on medical devices in line with developments in European law. The new legislations in Switzerland are applicable since 26 May 2021 for medical devices (MedDO) and 26 May 2022 in vitro diagnostic medical devices (IvDO) like in the EU

G/TBT/N/P HL/304	Philippines	Date of Distribution: 03 July 2023 Deadline for Comments: 21 July 2023	License to operate of health product establishments	The regulation aims to introduce technical procedures on inspection and updated list of documentary requirements for the issuance of License to Operate aligned with international standards and automation of FDA licensing application systems. It also intends to repeal Administrative Order No. 2020-0017 (Revised Guidelines on the Unified Licensing Requirements and Procedures of the Food and Drug Administration Repealing AO No. 2016-0003). The regulation provides the list of updated documentary requirements for LTO applications, in addition to other technical requirements that shall be presented during inspection of the FDA-covered establishments. Further, the FDA's intention to comply with international standards in terms of health shall be institutionalized in the agency's regulatory process. Hence, compliance with the World Health Organization – Global Benchmarking Tool (WHO-GBT) is necessary.
