Addendum XXVII to Amendment 3 to the Interstate Fishery Management Plan for American Lobster, approved in May 2023, triggered changes to the current minimum size for lobsters caught in LCMA 1 (inshore Gulf of Maine) as of 16 October 2023. Therefore, a series of gradual changes to minimum size for lobsters caught in LCMA 1 will begin 1 January 2025, starting with an increase to the minimum size in LCMA 1 from 3 1/4 inches (82.5 mm) to 3 5/16 inches (84 mm) and to 3 3/8 inches (86 mm) on 1 January 2027. These increased minimum sizes will be the smallest minimum size in effect for American lobster harvested in the United States under the Interstate Fishery Management Plan for American lobster. Draft Addendum XXX considers whether to apply the Addendum XXVII minimum size increase recommendation to possession of American lobster, which, under U.S. law, would mean that the smallest minimum size for imports would match the smallest minimum size in effect for American lobster, which, under U.S. law, would mean that the smallest minimum size for imports would match the smallest minimum size in effect for American lobster harvested in the United States.
