It applies to all vehicles designated for road circulation, except for agricultural tractors which are only incidentally used for the carriage of persons or goods by road. Worth mentioning is that this draft standard is technically identical with ISO 3833:1977 (confirmed 2019).

These amendments affect the certification procedures for fuel efficiency standards and related requirements. These amendments increase compliance flexibility, harmonize with other requirements, add clarity, correct errors, and streamline the regulations. Given the nature of these changes, NHTSA does not expect either significant environmental impacts or significant economic impacts for any sector.
