G/TBT/N/NZL /109/Add.2	New Zealand	Date of Distribution: 30 September 2022 Deadline for Comments: Not Indicated	Smoked tobacco products - Addendum	As per G/TBT/N/NZL/109/Add.1, the Smoke free Environments and Regulated Products (Smoked Tobacco) Amendment Bill was introduced on 21 June 2022. The Bill gives effect to the key regulatory measures agreed under the Smoke free Aotearoa 2025 Action Plan. This includes proposed new requirements for smoked tobacco products that were previously notified to the TBT Committee in December 2021, such as limits on the quantity of nicotine and other constituents of smoked tobacco products.
