The Construction Standard will classify G-PAPR according to the shape of the mask, the air capacity and the substances of toxic gases to be purified by the canister or cartridge, and will prescribe additional requirements of structure and strength, test methods of the performance and items to be indicated.

The meeting will cover the analytical framework, models, and tools used to evaluate potential standards; the results of preliminary analyses performed by DOE; the potential energy conservation standard levels derived from these analyses (if DOE determines that proposed amendments are necessary); and other relevant issues.
