At the same time, for lease agreements that expire during the period of martial law and within a calendar year after its termination

				or cancellation, provisions are made for their automatic extension. The Law also regulates legal relations regarding the use of hydraulic structures for aquaculture purposes and introduced a digital mechanism for obtaining permits.
