This rule imposes no additional costs to chemical shippers or vessel owners.
<u>G/TBT/N/USA/</u> 2067	United States	Date of Distribution: 20 November 2023 Deadline for Comments: 31 December 2023	Laundry detergents containing nonylphenol ethoxylates	The proposed action will add laundry detergents containing nonylphenol ethoxylates (NPEs) as a Priority Product to the Priority Products List. This listing applies to any product that is placed into commerce in California that contains NPEs, and that may be marketed, sold, or offered for sale as a chemical substance to clean or remove soil or unwanted deposits from laundered clothes and textile products, such as sheets and tablecloths. This includes, but is not limited to, laundry detergents of any form, including granules, liquids, powders, tabs, crystals, or pods, that are used in washing machines, for 4 hand washing, or as part of a laundry system. Detergents intended for use as a pre-soak or pre-spotter, or with fabric or color protection
