G/TBT/N/G BR/68	United Kingdom	Date of Distribution: 05 September 2023 Deadline for Comments: 03 November 2023	Ice wine	These measures introduce into Great Britain (GB) law a prohibition on the marketing of ice wine unless the definitions, detailed in the Regulations, are met. The ice wine provisions as follows - No person may market a product using a term mentioned below unless the product is a wine made exclusively from grapes naturally frozen on the vine. The terms referred to above are: (a) 'ice wine'; (b) 'icewine'; (c) 'ice-wine'; (d) a term similar to a term mentioned in point (a), (b) or (c); (e) a term having the same meaning as a term mentioned in point (a) not (b) or (c) in a language other than English; (f) a term mentioned in point (a), (b) or (c) in a language other than English.

The main modifications of this amended regulation draft are: • establishing detailed HS Code of products that are covered by the regulation • updating the reference standard • updating the conformity assessment procedure on the surveillances phase.

This amendment covers revisions of some monomers and starting substances to be used in the production of food contact plastic materials and articles and changes to migration test rules. This regulation enters into force on the date of its publication. However, transitional period has been provided in Provisional Article 2.
