G/TBT/N/C/HL/660	Chile	Date of Distribution: 02 October 2023 Deadline for Comments: 30 November 2023	Aerial receiving digital terrestrial television	The notified regulation is aimed at amending Exempt Resolution No. 7.219 of 2009, as amended by Exempt Resolution No. 7.316 of 2010, both of the Undersecretariat of Telecommunications, which establishes the minimum technical specifications to be met by digital terrestrial television receivers, as it did not include the aerial, an element fundamental to their proper functioning. The definition of the receiving aerial has therefore been amended, indicating that it is a "physical device that allows for the transformation of the electrical field of the signal transmitted by air and the voltage needed for the electronic elements of the receiver to function correctly and for digital signals to be decoded.

They will enter into force on 29 April 2024, alongside the wider product security regime that they form a
