Nevertheless, both the old edition and the newly revised standard will apply until 7 August 2024. During this time, products may be tested according to both editions. The requirements of all sections of the newly revised standard shall be mandatory except for the following: • Sub-sections 7.201, 7.202, 7.203, 7.204, and 7.205 of section 7 "Marking and instructions"; • Sub-section 10.201 dealing with energy efficiency; • Sub-section 10.202 dealing with the quality of dishwashing; • Sub-section 10.203 dealing with the quality of
