This standard cancels and supersedes its last edition issued ES 2623-3/2017. It should be noted that The Ministerial Decree No. 463/2020 (3 pages, in Arabic) amended by Ministerial Decree No. 474/2020 (2 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/280 dated 11 January 2021, mandated among others the earlier version of this Standard.
