This addendum is to inform that this draft Ministerial Regulation mandates safety glazing materials for vehicles to conform to the Thai Industrial Standard TIS 2602-25XX (20XX) Safety Glazing Materials for Vehicles.  This revised standard applies to safety glazing materials intended for installation as windscreens or other panes, or as partitioning, on vehicles of category L with bodywork, M, N, O, and T.  This draft Ministerial Regulation will come into force after 180 days following the date of its publication in the Government Gazette.
