These regulations will introduce a ban on the sale and supply of: single-use electronic cigarettes that are not rechargeable, not refillable or are neither rechargeable nor refillable. single-use electronic cigarettes retaining both nicotine containing e-liquid and non-nicotine containing e-liquid.

In May 2024, Government agreed to extend the transition period for the inhibitor substances listed in the Order by two years.
