A public hearing is not scheduled. Any interested person or his or her authorized representative may submit written comments to CDFA-DMS that are relevant to the proposed regulatory action.

Its objective is to protect the life and integrity of people by demanding technical performance and safety requirements on workshops, equipment and conversion and maintenance processes of gas systems for vehicular use, as well as preventing practices that could mislead consumers. Likewise, it is applicable to workshops and their fuel conversion processes for vehicle use, in addition to maintenance workshops for dedicated vehicles, maintenance and inspections of such vehicles, as well as fuel conversion equipment. fuels (Natural Gas, AutoGLP) for vehicular use, which are manufactured, imported or marketed in Colombia.
