The Regulation covers the issuance of SNI certificate using type 5 certification scheme, production process assessment and implementation of ISO 9001:2015, including product quality testing based on: SNI ISO 13006:2018 Ceramic tiles – Definition, classification, characteristics and marking, HS Code 6907.21.91, 6907.21.92, 6907.21.93, 6907.21.94, 6907.22.91, 6907.22.92, 6907.22.93, 6907.22.94, 6907.23.91, 6907.23.92, 6907.23.93, 6907.23.94, 6907.40.91; dan 6907.40.92.; and Technical Specification of Ceramic Tiles. Domestic or imported ceramic tiles product that has been produced before this Ministerial Regulation comes into effect can still be distributed to a maximum of 1 (one) year from the date of enforcement.
