A previous proposal to remove all standards of fill was not adopted following public comments. These amendments aim to provide industry members greater flexibility in container sizes, enhance trade opportunities, and offer consumers more options. The rule takes effect on January 10, 2025. <u>G/TBT/N/U SA/2168/A dd.1</u>	United States	<p>Date of Distribution: 13 January 2025</p> <p>Deadline for Comments: 14 March 2025</p>	Food date labeling	The Food Safety and Inspection Service (FSIS) and the Food and Drug Administration (FDA) have extended the comment period by 30 days for a joint Request for Information (RFI) on date labeling practices, consumer perceptions, and its potential effects on food waste and grocery costs. The new deadline for comments is March 5, 2025. The extension, prompted by an industry association's request, allows stakeholders more time to respond. The RFI, originally published on December 4, 2024, is identified by Docket Number FSIS-2024-0021, with documents and comments available on Regulations.gov. Feedback from WTO Members and stakeholders submitted by the deadline will be shared with FSIS and added to the Docket.
