The Regulations establish three key food safety elements: licensing, traceability, and safety requirements related to the preparation of food and preventive control plans. These elements apply to all food that is imported, or prepared for export or inter-provincial trade. Canadian and international stakeholders will have a period of six months to get ready to meet the new requirements before they come into force on 15 January 2019.
